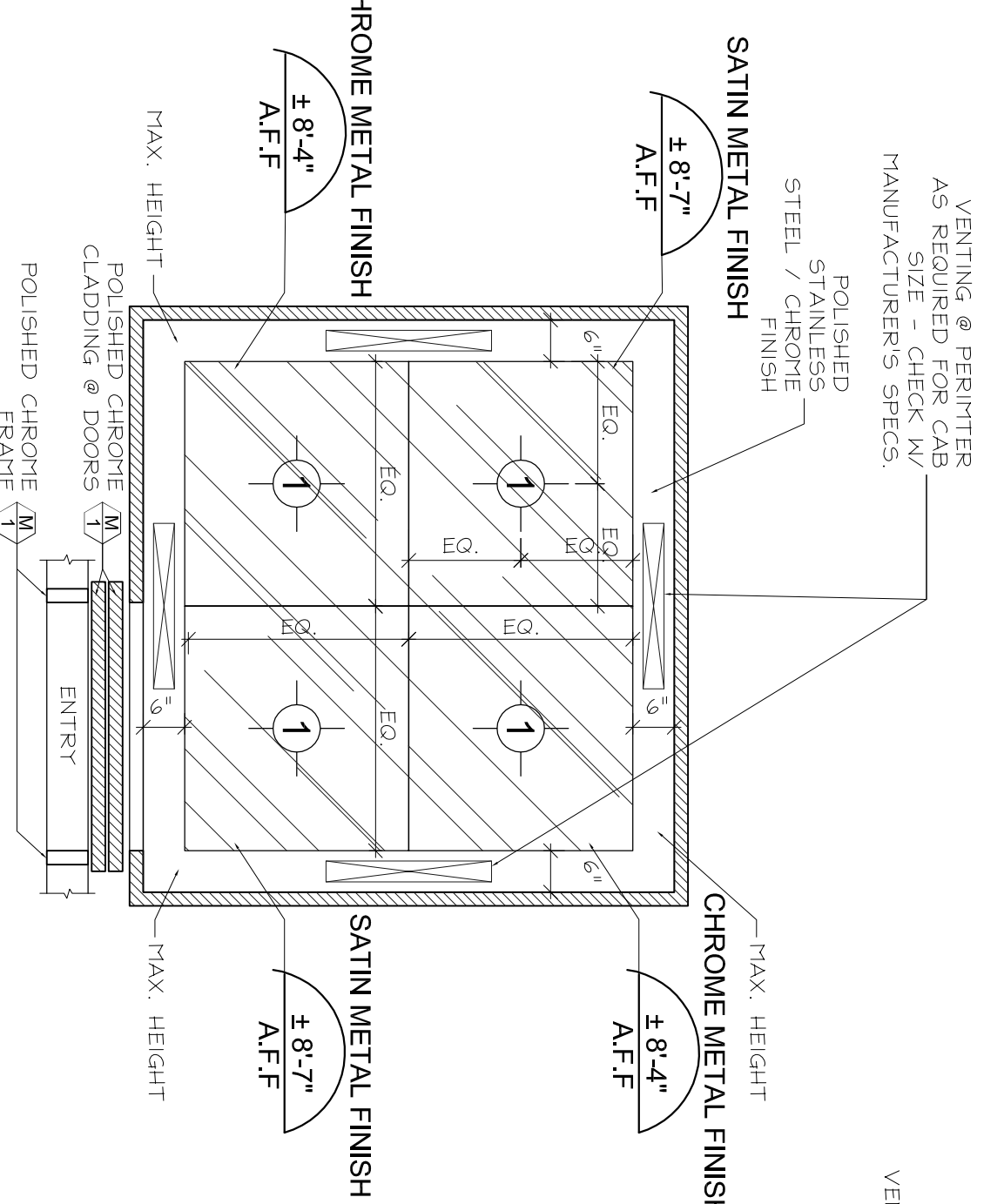
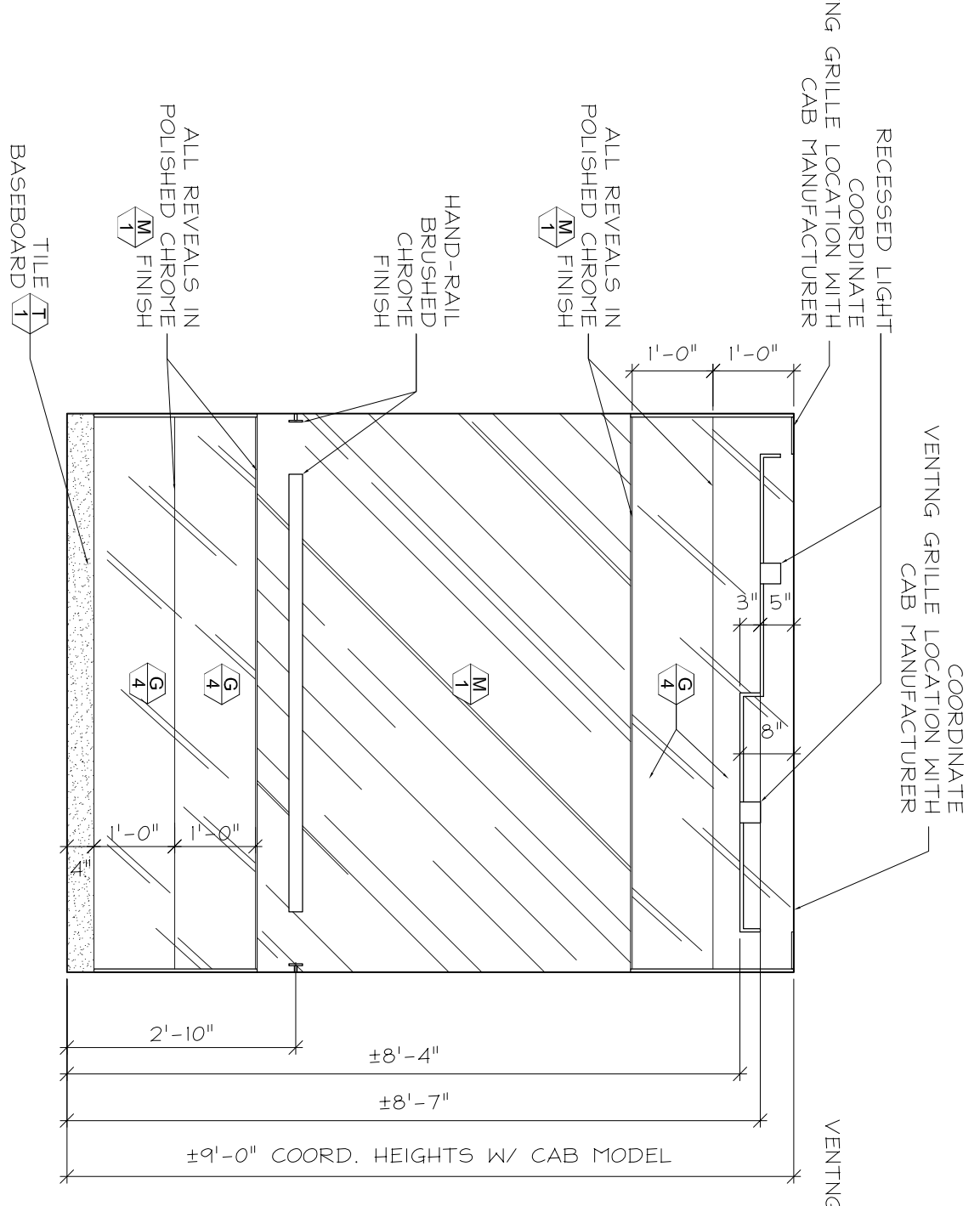


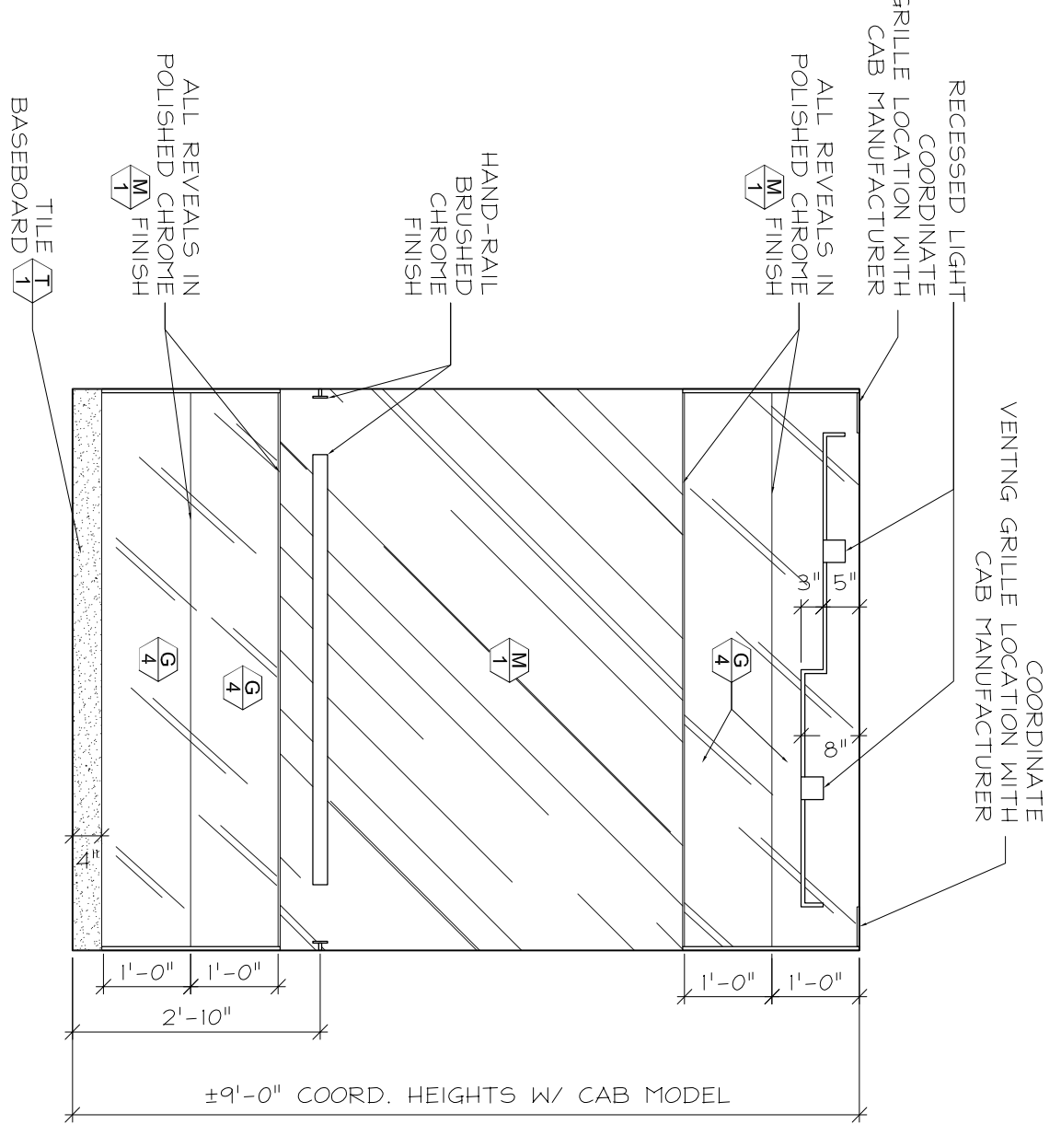
G1 ELEVATOR CAB - FLOOR PLAN



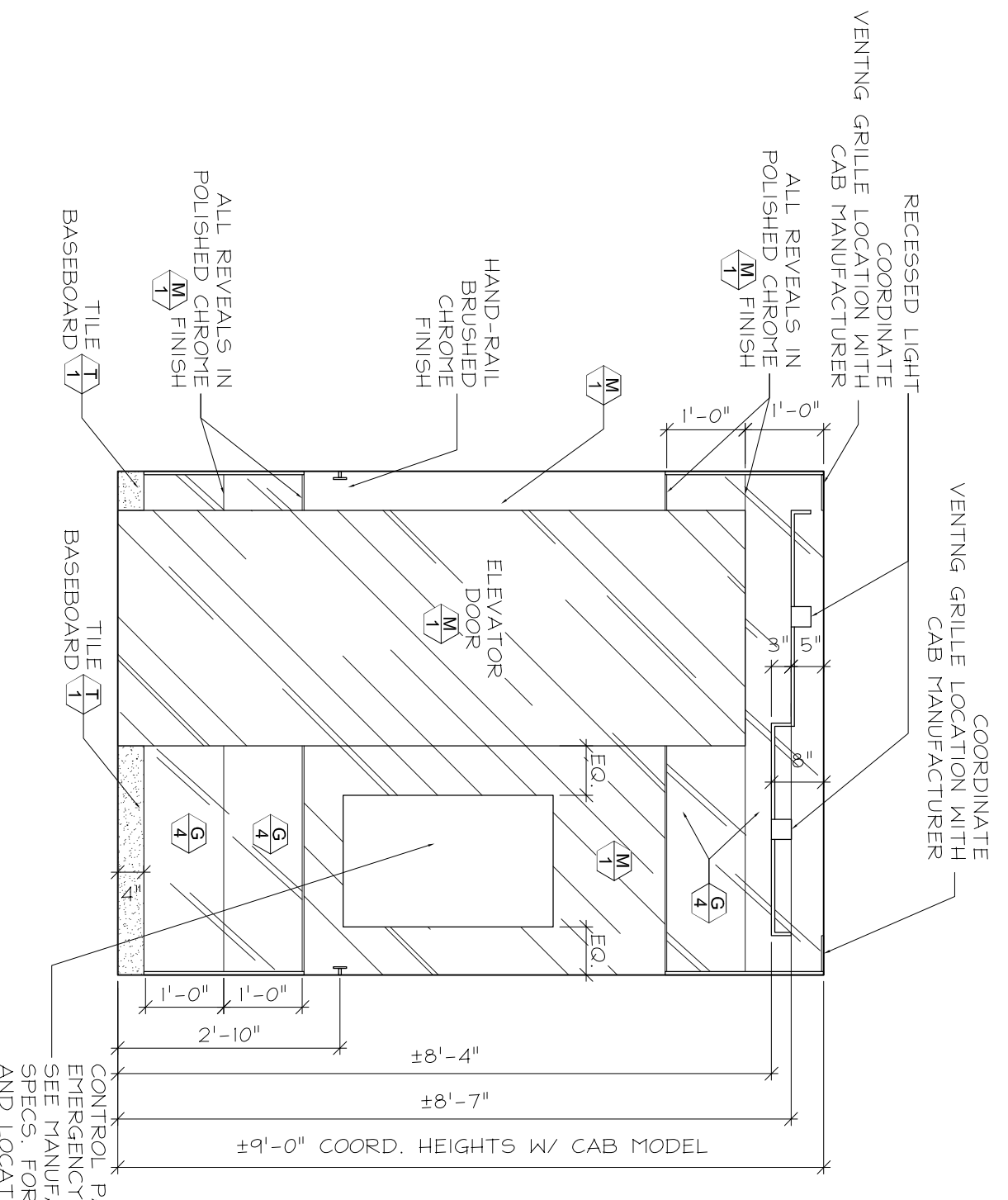
G2 ELEVATOR CAB - CEILING PLAN



G3 ELEVATOR CAB - ELEVATION



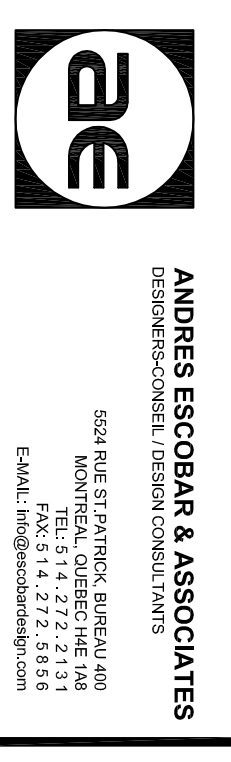
G4 ELEVATOR CAB - ELEVATION
